

Staveley with Ings Community Plan Action Plan 2021/23 and Forward Look to 2031

Introduction

If you talk to anybody in the locality they say that Staveley with Ings is a great place to live with an active and vibrant community. In the parish there is so much enthusiasm and passion and so much to be celebrated, captured and developed.

But things change, residents come and go, some businesses leave and others set up, priorities change. In 2021 we face the twin challenges of recovering from the pandemic and responding to the climate emergency.

Staveley with Ings need to plan ahead if we are to look after the things we value, develop new initiatives and respond to pressures. This plan aims to set out a direction for the next 10 years, within a process that allows regular reflection and renewal, and enables our community to share achievements as we emerge from this most difficult period.

Delivery of the Action Plan will be guided by five principles:

- Responding to the climate emergency, placing an emphasis on creating and nurturing a sustainable environment
- Continuing to strengthen our community, and building resilience for emergencies such as flooding or a pandemic
- Improving communications, and encouraging and enabling greater community engagement and more participative decision making
- Working effectively with partners, aligning our priorities as far as possible
- Ensuring that our actions are economically and socially sustainable.

In putting the Plan into practice we need to make sure that, where we can, we promote these principles, and that at the very least we do not undermine them.

Why a Community Plan and why now?

In the past we've had a Parish Plan which has been developed by the Parish Council in consultation with residents, businesses and external partners.

This Community Plan has been developed by the community, through several channels, very much for the community. It challenges us collectively to deliver ambitious change over the next 10 years.

We have set out an initial Priority Action Plan which will run to March 2023 when it will be reviewed and refreshed. We will continue to review progress every 12 months, and update where necessary, celebrating achievements and understanding why progress may have proved more difficult than expected.

There are some areas where we can move things forward ourselves, as individuals or as organisations, and action is already in hand for some of the 16 Priority Actions. For example, discussions are underway to tackle the problems of flooding and sewage (Priority Action 2); the Abbey Development Group is engaging with the community to discuss the future of The Abbey (Priority Action 3); and Cumbria County Council has carried out preliminary consultation on traffic in the parish (Priority Action 4).

Cumbria Wildlife Trust has developed an active programme of work in our surrounding woodlands, with both school pupils and local residents involved (Priority Action 6). Staveley with Ings Together has begun to co-ordinate volunteers who are able to offer support to those in need (Priority Action 9), and the growing numbers of allotments together with the Big Onion have laid the foundations for growing more food locally (Priority Action 10). SPPAG is championing the importance of continuing to improve facilities for play (Priority Action 14), and the History Society has documented our local assets in the built environment (Priority Action 16).

In some areas we will need to work with external partners such as the Lake District National Park Authority, South Lakeland District Council, Cumbria County Council, United Utilities and the Environment Agency. Their priorities will not necessarily be the same as ours, and we will need to work patiently with them to achieve our goals. This can take time, and we would like to thank those partners who have taken an interest in the development of this Plan and with whom we are already working.

The Annex provides examples of some of our potential delivery partner organisations.

We also need to continue to work together to agree how we want to tackle some longstanding concerns. For example, how can we make our villages better places to live, what do we feel about further development in the parish, and how can we balance the range of views about traffic and parking? There are no easy answers, and we need to understand and work with the range of views.

The most recent Parish Plan for Staveley with Ings was published in 2013. So, 8 years on, this is a good time to recognise what we have achieved, and to renew the Community Plan for the 2020s.

Who is “The Community”?

Staveley with Ings Parish includes Hugill, Nether Staveley and Over Staveley. The most recent information about our population comes from the 2011 census which shows that 1593 people live within the Parish in 733 households. (This will be updated as soon as the results of the 2021 Census are available.)

Overall the population is older than the average for England with 199 people aged 65-74 years and 217 people aged 75 years and older (26.1% compared with the England average of 16.3%). In 2011 the population was 96% white British, although this may have changed over the last 10 years.

There is a high level of home ownership and, compared with England as a whole, an under-representation of social housing. A total of 116 (15.8%) households were classified as having “no usual residents”. Some of these properties are likely to be second homes and/or holiday rentals. There is a higher than average ownership of cars and vans which may to some extent reflect the shortcomings of local public transport.

The Parish is well connected with road and rail access and conveniently located for visits to the Lake District National Park, the historic market town of Kendal, as well as the motorway network via the M6. It is near the SE border of the Lake District National Park and provides the main access to the Kentmere Valley for both walkers and cyclists.

There are 60+ businesses within the parish serving both residents and visitors. Over one quarter of those in work are self-employed, much higher than the England average of one in ten. The importance of visitors is to some extent reflected in the main local occupations – wholesale and retail trades followed by accommodation and food services.

We are an active, caring and capable community who are good at working together and fortunate to have great resources. We have places to meet and a wide network of active local organisations including Cumbria Wildlife Trust, Staveley Crown Bowling Club, Staveley Football Club, Staveley History Society, Staveley Village Association, Staveley Women’s Institute, Stick and Wheel, and Sustainability Energy Network in Staveley (SENS).

Many of our wide range of local businesses are actively involved in the community. This has been particularly apparent over the past 16 months as businesses have provided additional support for those who need it, such as home deliveries for those who were self-isolating.

How did we go about developing the Community Plan?

We have aimed to give everyone in the community an opportunity to contribute their suggestions to the Community Plan as it developed. It has been a long process, made more complicated by the pandemic. We have used a handful of different ways to engage people, including face to face meetings, paper and online surveys, and focus groups, as well as zoom meetings during the lockdowns.

We started by reviewing the 2013 Parish Plan identifying the successes and reflecting on those actions that are yet to be achieved. Some of our most significant progress includes regenerating Jack's Corner and the Barley Bridge viewing point, introducing a new dog control order on the Ayland Recreation Ground, increasing the number of allotments, and completing a housing needs survey.

In addition the community showed that it was up to the challenge when the need arose. For example, we saved Craggy Wood and extended access to Reston Scar in part through generous donations from local residents. And following the devastation of Storm Desmond, the Parish Council established a Flood Action Plan as part of the Parish Emergency Plan, with a WhatsApp group set up for core volunteers to monitor flood and river issues. With funding obtained from the Cumbria Foundation we now have a range of resources with separate stores in both Staveley and Ings in case of further flooding.

In 2018 the Parish Council conducted an electronic survey using Survey Monkey, which resulted in around 150 responses. There is further information about this on the Staveley with Ings Parish Council website - <http://www.staveleywithingspc.co.uk/communityplan>.

Following Storm Desmond, Staveley was designated as one of three Pioneer Projects to look for better ways to manage and prevent flooding in the future. We received funding from DEFRA (the Department for Environment, Food and Rural Affairs) via the Environment Agency to run a series of public participation events called The Conversation in 2019. A total of 136 people attended meetings and 129 pupils at Staveley Primary School were also involved in discussing what they value about their village, and their hopes for the future for Staveley with Ings. During 2020 we drew on this work, as well as on a further survey undertaken by SENS on Active Travel to which there were 62 responses, to begin to develop the Community Plan. In October 2020 we then asked all those who live and work in Staveley and Ings to contribute to an online survey specifically about the content of emerging Plan. We asked for ideas for the Community Plan across the five Strategic Areas which were identified during The Conversation, and this is a summary of what you told us.

- **Nature and Environment** – Enjoying the landscape and nature of where we live came through as something many people valued enormously. Ideas for action ranged from planting wildflower seeds, to looking at community scale renewable energy options, to doing a tree survey of the parish. There’s also real energy around reducing the damage we do to our environment and addressing climate change.
- **Staveley with Ings Society** – We are a mixed and accepting community; we recognise opportunities to learn from each other and to get things done together. The feeling of community spirit people describe has been consistent and powerful throughout the whole process. There is a huge desire to celebrate and grow this nourishing, supportive and creative aspect of our lives.
- **Our Economy** – We value the variety of shops and leisure services we have on our doorstep and many people are willing to take steps to help, support and encourage existing businesses. There is a real enthusiasm for exploring local food supply chains, to make sure we support local people as far as possible. Understanding the role of visitors in our community and economy is also crucial.
- **Our Services and Facilities** – The range of places and spaces we use as we go about community life is something we are very proud of. Among other things, we have places where we can play, eat, socialise, do sport, be creative and take care of ourselves and others. The community recognises the crucial role of the services provide by the School, the Doctors’ Surgery and the Fire Station and others who look after us. There is real concern about the future of The Abbey Care Home site, and how we can continue to care for our elderly residents, close to home.
- **Planning and Making Decisions** – Some really challenging ideas have emerged here around spatial development and what is right for the future of the Parish. The community and the Parish Council have an important role in decisions which affect us all. To be effective we should work together to influence the plans and policies of others. This includes (not exclusively) roads and transport plans, housing and other development, and how we continue to access health and education services.

We asked people what actions they were already taking, what they were planning to do in the future, and what they thought the community as a whole should do. There were many rich ideas as well as thoughtful offers of help, on-line, on paper and in emails.

This has not been the easiest time to develop a Community Plan, and the circumstances have made it harder for many people to have their say.

We invited those people who completed the latest survey to tell us if they would like to be involved in bringing the Plan together, and we invited this group along with others to participate in prioritising the five Strategic Areas via Zoom meetings. The discussions brought a fresh community perspective which helped shape the Community Plan.

What’s in the Priority Action Plan?

The most difficult thing has been to choose from the long list of things we would like to do, and to put forward a shorter list of Priority Actions on which we will concentrate up to March 2023.

The need to improve communications came up across all five Strategic Areas. Priority Action 1 sets out how we plan to improve our communications face to face, online and on paper. This will underpin the delivery of the Community Plan by making it easier to share information and ideas, and to support each other, as well as providing an increasingly useful source of information for residents, businesses and visitors.

Three further immediate priorities were raised repeatedly through the survey and subsequent discussions:

- To resolve the problem of sewage and wastewater overflowing when it rains (Priority Action 2)
- To agree with the community how The Abbey site should be developed (Priority Action 3)
- To tackle longstanding problems with travel and transport (Priority Action 4).

Community representatives are already working with partner organisations on each of these, and it is crucial that we make early progress over the coming months.

Priority Actions 5-16 were identified through the 2020 survey and highlighted as important in discussions in the five Strategic Area Groups. It is hoped that local organisations and local people can help us to make progress with these between now and March 2023.

Examples include enabling people to engage with nature, helping community groups to get up and running again post-pandemic, promoting sustainable local food production, continuing to improve local playgrounds, and developing a directory of local assets in the built and landscape environment.

A Forward Look to 2031

All other Priority Actions identified through the survey and the five Strategic Area Groups will be published on the Parish Council website. We probably won't be able to get to grips with these this year, although we will be opportunistic, for example, if grant funding becomes available or if there is an offer of support.

All Priority Actions will be kept under review and may receive higher priority from 2023 onwards if they have not been completed by then.

This is not the end ...

The Community Plan is your plan. If it is to respond to the needs and aspirations of everyone in the parish it will have to evolve and develop over the next 10 years.

It is designed to be dynamic and responsive to changes – not just emergencies like flooding and the pandemic but longer-term changes and challenges – economic, environmental and social.

The plan was written by volunteers and we hope it will be driven by volunteers – not only by those who like to sit, talk and write plans but those who want to do things to improve our community and our village environments.

An integral part to the design of the plan is the process of its delivery. This means we need maximum engagement and support. No one body can deliver the ambitious plan alone!

To keep up the momentum the **Parish Council** will discuss progress in each of the five Strategic Areas on a rolling programme.

To keep the plan alive, we hope that **individuals and local groups** will volunteer to take the lead and carry out some of the actions in the plan.

To support delivery of the Plan and to keep the Priority Actions on track a **Community Plan Delivery Group** will be set up. Its roles might include:

- Meeting regularly to overview delivery of the plan and monitor how the actions are progressing.
- Offering support and encouragement, when needed, to those involved in delivering the actions in the plan.
- Considering how each action is going to be implemented. This might involve encouraging an already established group to take the lead or forming a new group of interested volunteers.
- Encouraging individuals and groups to get involved by alerting members of the community to opportunities and needs.
- Supporting groups and individuals who are delivering the plan by alerting them to grants that might be available locally or nationally, and if necessary helping with an application.
- Responding to changes within the community and its aspirations through the annual review process and the development of the next Action Plan.

Things to think about when working on the Actions in the Plan

- Are we doing everything we can to respond to the climate emergency?
- Are we encouraging people to get together socially and build strong relationships across the community?
- Are we enabling as many people as possible to get involved and take an active part in decision making?
- Are we working effectively with our partners?
- Are we making sure that our achievements will be sustainable?

How will we know the Plan has been a success?

We will know the Plan is being successful in three main ways:

- The Actions in the Plan have been carried out and have been effective in improving our villages.
- More of us have been involved in improving our community and environment by taking actions, sharing thoughts and ideas and attending events and meetings.
- The Action Plan is reviewed each year and a new plan is written drawing on creative ideas from the community.

Get involved?

The Community Plan belongs to the community, and we need everyone to be involved in taking the Actions forward. In the Community Plan there are many ideas about what you might do as an individual, as a family, as a friendship group or through an existing organisation.

Everybody can be involved in turning the plan into action. You can:

- Join one of the local groups who have committed to lead or be involved in one of the Priority Actions
- Come along to Parish Council meetings and have your say
- Take individual action, for example using some of the ideas in the plan to create a more biodiverse environment in your garden, continuing to shop locally, and supporting local groups to bounce back after the pandemic
- Join the Community Plan Delivery Group to help keep things moving.
